

State Legislative Update

April 2022

Enacted

With the conclusion of April, a majority of states (26) are no longer in session and a multitude of bills have been enacted. Of particular note:

- Kansas's KS HB 2605 expands and clarifies the requirements for the Veterinary Training Program for Rural Kansas at Kansas State University College of Veterinary Medicine and creates an advisory committee to oversee the program.
- In **Maine**, legislation (<u>ME LD 482 (S.P. 186)</u>) establishes the framework and mechanics for pet insurance.
- Despite opposition by the AVMA and the Maryland Veterinary Medical Association, the Maryland legislature passed a bill (MD HB 22) that bans the declawing of cats unless for therapeutic use. Maryland is the second state to enact a declaw ban. The state of New York banned declawing of cats in 2019.
- Nebraska's <u>NE LB 848</u> authorizes, when funds are available, the development and execution of county or other local emergency management organizations' catastrophic livestock mortality disposal plans for a response to a disease, natural disaster, or other emergency event resulting in catastrophic livestock mortality.
- Virginia's VA HB 551 exempts veterinarians from sales and use tax on the purchase of prescription medicines and drugs that are administered or dispensed to patients within a veterinarian-client-patient relationship (VCPR). Championed by the Virginia Veterinary Medical Association, this legislation repeals provisions of current law that provide that a veterinarian dispensing or selling medicines or drugs on prescription shall be deemed to be the user or consumer of all such medicines and drugs.
- A new law in Virginia (<u>VA HB 1330</u>) requires veterinarians to scan unidentified companion animals for embedded microchips in an attempt to identify the lawful owners.

Introduced

- Opposed by the Delaware Veterinary Medical Association and the AVMA, Delaware's
 <u>DE SB 258</u> would provide for damages of up to \$15,000 in veterinary bills for injuries to a
 pet, the fair market value of a deceased pet, and up to \$15,000 for emotional trauma
 suffered by the pet's owner (noneconomic damages).
- In **Missouri**, MO HB 3017 would appropriate funds for the design and construction of a new veterinary laboratory at the University of Missouri. **Rhode Island's** RI HR 8155 RI HR 8155 would appropriate \$100,000 to fund a veterinarian at the Wildlife Clinic of Rhode Island.
